ORDER REQUIRING CORRECTION

On March 22, 1999, The City of Hannibal and Missouri Rural Electric Cooperative (Joint Applicants) filed a document entitled Joint Application. The document stated that it was a joint application ". . . pursuant to Section 393.190, RSMo, for an order authorizing a change of electric service provider. . . ."

Section 393.190 RSMo deals with approvals of incorporations and franchises by the Commission; however, changes of electric service providers, municipalities and co-operatives are nowhere mentioned.

4 CSR 240-2.060(1)(D) states: "All applications . . . shall include . . . [r]eference to the statutory provision or other authority under which relief is requested." Since this application is deficient in that respect, the Joint Applicants will be given ten (10) days from the date of this order to file a corrected application or be subject to dismissal.

IT IS THEREFORE ORDERED:

- 1. That the City of Hannibal and Missouri Rural Electric Cooperative be given until May 10, 1999 to file a corrected Joint Application or be subject to dismissal.
 - 2. That this order shall become effective April 28, 1999.
