**PROPOSED PROCEDURAL SCHEDULE**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), on behalf of itself, Missouri Gas Energy (“MGE”), the Office of the Public Counsel (“OPC”), and Enbridge Pipelines (“KPC”), collectively the “Movants,” and submit the following proposed procedural schedule for the Commission’s consideration:

1. On April 12, 2005, the Commission issued an Order Consolidating Cases and Establishing Procedural Schedule where Case No. GR-2002-348 and GR-2003-0330 (lead case) were consolidated. Due to numerous serious issues that arose after that order was issued MGE requested, with agreement of the parties, and the Commission ordered on October 20, 2005, a procedural schedule modification. On February 24, 2006, Staff’s request to suspend this procedural schedule, due to its own serious situation, the Commission suspended this procedural schedule. On March 28, 2006, Staff filed its motion for abeyance or consolidation in case no. GR-2005-0104. On April 28, 2006, consolidation with this and other cases was denied.

2. On April 28, 2006, the Commission ordered Staff to file this procedural schedule by May 12, 2006, on behalf of all of the parties in the above-captioned case, to seek resolution of the matters in this case.

3. Movants respectfully propose that the Commission adopt the following procedural schedule for this case:

Surrebuttal Testimony	July 19, 2006
Statement of Issues, Order of Issues, List of Witnesses, and Order of Cross	July 25, 2006
Prehearing Briefs	August 18, 2006
Evidentiary Hearing	August 28-30, 2006

**WHEREFORE**, the Staff, on behalf of all of the parties to this case, respectfully request that the Commission issue its order adopting the procedural schedule set forth above.
