#### JOINT PROPOSED PROCEDURAL SCHEDULE

Pursuant to the Commission's Order of December 22, 2010, KCP&L Greater Missouri Operations Co. (GMO), the Staff of the Missouri Public Service Commission, the Office of the Public Counsel, and Industrial Intervenors Praxair, Inc. and Sedalia Industrial Energy Users Association (collectively, "Parties") propose the following procedural schedule with regard to the four issues noted by the Commission in Section II of its Order.

Although the dates proposed below do not commence with direct testimony for several months, both GMO and its regulated affiliate Kansas City Power & Light Co. (KCP&L) began their general rate cases on January 18, with certain GMO-specific issues set for February 14, 2011. All counsel participating in the subject case are actively involved in each of those rates cases. Since both of those proceedings are subject to procedural schedules requiring new rates to become effective in May and June, and given the anticipated complexity of the issues and the length of post-hearing briefs in those cases, the Parties believe that in this case -- which is not subject to an operation of law mandate -- major filings should not commence until the GMO and KCP&L rate cases are close to being submitted.

In light of those events, the Parties propose the following dates:
