ORDER MODIFYING PROCEDURAL SCHEDULE

On June 25, 1999, The Empire District Electric Company (Empire), the Staff of the Missouri Public Service Commission (Staff), Southwest Electric Cooperative, Ozark Electric Cooperative, and Webster Electric Cooperative, jointly filed a nonunanimous stipulation and agreement regarding the issues in this case. The City of Springfield, Missouri, by and through the Board of Public Utilities, (City of Springfield) is an intervenor in this case and is not a signatory to the stipulation and agreement. The Office of the Public Counsel also has not signed the stipulation and agreement.

The stipulation and agreement recognizes that surrebuttal testimony is to be filed in this case on July 1. The parties who signed the stipulation and agreement agreed that nonsignatory parties may be allowed an additional week to file surrebuttal testimony so that they may address the stipulation and agreement if they wish to do so.

On June 29, the City of Springfield filed a Request for Hearing and for Extension of Time to File Cross-Surrebuttal and for Expeditious Consideration. The City of Springfield asks that it be allowed at least until July 8, and preferably longer, to prepare testimony responsive to the Nonunanimous Stipulation.

The Commission will grant the City of Springfield's motion for additional time in which to file surrebuttal testimony. The procedural schedule previously established in this case will be modified to allow for the filing of surrebuttal or cross-surrebuttal testimony by all parties on July 8. The City of Springfield requested a later date but that request will not be permitted because to do so would require the Commission to also push back the dates for the filing of the statement of issues and witnesses on July 15 and the filing of statements of position on July 22.

IT IS THEREFORE ORDERED:

1. That the following modified procedural schedule is adopted for this proceeding:
