## ORDER ESTABLISHING PREHEARING CONFERENCE AND ORDER DIRECTING FILING OF PROCEDURAL SCHEDULE

On April 17, 2000, the Director of the Division of Manufactured Homes and Modular Units of the Missouri Public Service Commission (Director) filed with the Missouri Public Service Commission (Commission) a complaint against Discount Manufactured Housing, Inc. (Discount) for allegedly altering a manufactured home to which a seal had been affixed and failing to correct a code violation within 90 days after being ordered to do so by the Commission. On May 17, 2000, Discount filed a request for voluntary mediation. Also on May 17, 2000, the Director filed his response, stating that he had no objections to mediation.

On January 9, 2001, the Commission ordered the Director and Discount, to file, no later than February 8, 2001, a joint report on the status of this case.

Discount filed a letter concerning the case status on February 8, 2001. Discount stated that the last correspondence it received from the Director was on September 15, 2000, and that the letter was a request to

set a prehearing conference. Discount stated that it had provided a report from the mobile home manufacturer to the Director. Discount also claimed that

there is a letter forthcoming from HUD [i.e., Department of Housing and Urban Development] which...will express an opinion that the manufactured home in controversy is a permanent structure and therefore not subject to the regulations of the Missouri Public Service Commission.

Director also filed his case status report on February 8, 2001. The Director stated that because of the information and contention in Discount's letter, and because mediation had not worked, the Director believed the most efficient way to conclude the matter was to set a prehearing conference.

The Commission will schedule a prehearing conference to afford the parties the opportunity to discuss, define, and possibly resolve the issues presented in this case. The Commission will also set a date for the filing of a proposed procedural schedule to ensure that this case progresses.

#### IT IS THEREFORE ORDERED:

- 1. That a prehearing conference shall be held on Thursday, April 26, 2001, beginning at 10:00 A.M.
- 2. The prehearing conference shall be held in Room 305, located in the office of the Missouri Public Service Commission in Jefferson City, Missouri, on the main floor of the Governor Office Building, 200 Madison Street. The Governor Office Building meets the accessibility standards required by the Americans with Disabilities Act. - 3. That a procedural schedule shall be filed no later than May 10, 2001.

4. That this order shall become effective on February 19, 2001.
