ORDER APPROVING TARIFFS PURSUANT TO COMMISSION ORDER

On August 27, 1999, St. Joseph Light & Power Company (SJLP) submitted tariff sheets pursuant to an Order Approving Stipulation and Agreement dated August 17, 1999. SJLP filed substitute tariff sheets on October 4, 1999.
