ORDER SETTING PREHEARING CONFERENCE AND DIRECTING FILING OF PROCEDURAL SCHEDULE

Lake Region Water & Sewer Company (LRWS) filed an application on October 22, 1999, requesting a certificate of convenience and necessity authorizing it to construct, install, own, operate, control, manage, and maintain a centralized sewage collection and treatment system in an area in an unincorporated area of Camden County, Missouri, as an expansion of its existing certificated area.

The Commission issued an Order and Notice on October 26, 1999, directing interested parties who wished to intervene to do so by November 27, 1999. Although no timely applications to intervene were filed, the Commission has received two late-filed applications to intervene. The first one was filed on February 4, 2000, by Bristol Bay Condominium Owners Association, Inc., The Falls Condominium Owners' Association, Inc., and Regatta Bay Owner's Condominium Association, Inc. (the "Association Intervenors"). The second one was filed on February 7, 2000, by Southwood Shores Condo

Owners Association, Inc. (Southwood). On February 14, 2000, LRWS filed a Response to Motions for Leave to Intervene Out of Time. LRWS argued that the motions were untimely and did not establish good cause for the delay. The Commission issued an order on February 17, 2000, granting both applications to intervene out of time.

A prehearing conference should be scheduled to afford the parties the opportunity to discuss, define, and possible resolve the issues presented in this case, or at least to agree on a procedural schedule. The Commission will also set a date for the filing a proposed procedural schedule in order to ensure that this case progresses in a timely manner.

IT IS THEREFORE ORDERED:

- 1. That a prehearing conference will be held on March 13, 2000, at 11:00 a.m. at the Commission's offices on the fifth floor of the Harry S Truman State Office Building, 301 West High Street, Jefferson City, Missouri.
- 2. That anyone with special needs as addressed by the Americans With Disabilities Act should contact the Missouri Public Service Commission at least ten (10) days before the prehearing at one of the following numbers: Consumer Services Hotline 1-800-392-4211, or TDD Hotline 1-800-829-7541.
- 3. That the parties shall file a proposed procedural schedule no later than March 23, 2000.

4. That this order shall become effective on March 7, 2000.
