ORDER APPROVING TARIFFS

On July 13, 1998, Warren County Water & Sewer Company (WCWS) submitted tariff sheets pursuant to an Order Approving Stipulation and Agreement dated June 18. On August 12, WCWS filed a letter extending the effective date of the tariffs until August 22, 1998. On August 13, WCWS filed certain substitute tariff sheets to correct errors and omissions that Staff had identified in the original filing.

On August 14, the Staff of the Commission (Staff) filed its memorandum. In that memorandum the Staff states that it has reviewed the tariffs, finds that they are correct and comply with the Commission's order, and recommends approval.

The Commission has reviewed the tariff filing and the Staff memorandum and has determined the filing to be in compliance with the Commission's order.

Pursuant to Ordered paragraph 4 of the Order Approving Stipulation and Agreement dated June 18, Gary L. Smith d/b/a Incline Village Water and Sewer (Incline) shall file a pleading with the Missouri Public

Service Commission notifying the Commission of the closing date of the sale of assets from Incline to WCWS within ten days after completion of the transaction.

IT IS THEREFORE ORDERED:

1. That Tariff No. 9800029, filed July 13, 1998, as corrected by substitute sheet filed August 13, 1998, by Warren County Water & Sewer Company, are hereby approved for water service on or after August 21, 1998: P.S.C. MO. No. 1 Original Sheets 1 through 29.

2. That Tariff No. 9800030, filed July 13, 1998, as corrected by substitute sheet filed August 13, 1998, by Warren County Water & Sewer Company, are hereby approved for sewer service on or after August 21, 1998: P.S.C. MO. No. 1 Original Sheets A through 41.

3. That this order shall become effective on August 22, 1998.
