ORDER REJECTING TARIFFS

The Commission issued its Report and Order in this case on November 26, 1997. On December 8, 1997, the Circuit Court of Cole County issued a temporary restraining order, extending the effective date of that Report and Order and setting a hearing on a motion for preliminary injunction. On December 22, 1997, after hearing, the Circuit Court issued a preliminary injunction, restraining and enjoining the Commission from enforcing the effective date of its original Report and Order.

On December 8, 1997, Missouri-American Water Company (MAWC) filed tariffs purporting to comply with the Commission's Report and Order of November 26, 1997. By letter of December 31, 1997, the effective date of those tariffs was extended from January 7, 1998 to January 21, 1998.

On January 15, 1998, MAWC filed substitute sheets and extended the effective date of the tariffs to February 2, 1998.

As the effective date of the Commission's Report and Order is stayed pending resolution in Circuit Court, the Commission finds it inappropriate to approve tariffs pursuant to this order. Both the original tariff filing of MAWC on December 8, 1997 and the substitute sheets, filed January 15, 1998, are hereby rejected.

IT IS THEREFORE ORDERED:

- That the tariffs filed December 8, 1997 by Missouri-American Water Company, and the substitute sheets, 'filed January 15, 1998, are hereby rejected.
- That this order shall become effective on February 1,
 1998.
