## PROPOSED NOTICE OF PUBLIC HEARINGS

COMES NOW Union Electric Company d/b/a AmerenUE ("AmerenUE" or "Company") and hereby states as follows:

- 1. On February 18, 2000 AmerenUE initiated this proceeding by filing tariff sheets which were designed to increase rates for the Company's Missouri service area.
- 2. On May 5, 2000 the Office of the Public Counsel ("Public Counsel") filed a request for local public hearings in this proceeding. The Public Counsel requested local public hearings at five locations within the Company's Missouri service area.
- 3. The Regulatory Law Judge assigned to this proceeding requested that the parties attempt to reach agreement on the language for the notice of the local public hearings which will be included on the bill of each of the Company's Missouri gas customers. AmerenUE is authorized to represent that all of the parties to this proceeding have agreed on the following language for the notice:

### NOTICE

Union Electric Company d/b/a AmerenUE has filed revised tariffs with the Missouri Public Service Commission (PSC) which would increase the company's Missouri jurisdictional annual gross revenues by approximately \$12 million or 14%. For the average residential customer, based upon average usage of 67 Ccf per month, the proposed increase would be approximately \$9.97 a month. The PSC may also address rate design which could affect customer class rate increases. The PSC has scheduled local public hearings at the following locations to give customers of AmerenUE an opportunity to comment on the proposed rate increase and any customer service issues.
