PROPOSED PROCEDURAL SCHEDULE

Come now the parties and submit the following to the Commission:

1. On June 12, 2006, the parties appeared at prehearing conference during which the regulatory law judge directed that the parties submit a proposed procedural schedule for Commission approval on or before June 19, 2006.

2. During the off the record portion of the prehearing the parties reached a consensus on filing dates, and jointly propose the following schedule:

Friday, July 7, 2006	The Developers of the Majestic Point Project and the Shawnee Bend Project, identified in Exhibit A and B to the Feasibility Study (Developers), shall submit to Applicant, and to Staff, all invoices and other data that establish the cost of engineering, construction and installation of the pipelines referred to in the Feasibility Study.

Friday, August 4, 2006	Staff's audit of the engineering, construction and installation costs for the pipelines and Staff's calculation of the Contribution in Aid of Construction Surcharge shall be submitted to Applicant and the Developers.

Friday, August 11, 2006	The parties file a stipulation and agreement. ¹

¹ Filing of the stipulation by the parties is expressly conditioned upon the filing by Applicant before August 4, 2006 of a duly executed modification to the contracts identified as Exhibits A and B to the Feasibility Study in substantially the form attached to this proposal. If the signed modification is not filed by that date, no stipulation will be filed and the matter will be subject to dismissal.

Wednesday, August 16, 2006

Staff files suggestions in support of stipulation.

Monday, August 21, 2006

Other parties file responses, if any, to Staff's supporting suggestions.

3. The parties are prepared to appear before the Commission to respond to questions about the stipulation either at an on-the-record presentation scheduled for that purpose or at one of the Commission's agenda meetings.

WHEREFORE, the parties respectfully request that the Commission approve their proposed procedural schedule.
