PROPOSED PROCEDURAL SCHEDULE

COME NOW the Staff of the Missouri Public Service Commission, St. Louis County Water Company, d/b/a Missouri-American Water Company ("Company"), the Office of the Public Counsel ("OPC"), and St. Louis County, Missouri, being all of the parties in this case, and jointly submit their Proposed Procedural Schedule to the Missouri Public Service Commission.

- 1. On October 25, 2001, the Commission issued its order that the parties attend a prehearing conference on November 2, 2001, and that they jointly prepare and file a proposed procedural schedule no later than November 9, 2001.
- 2. At the prehearing conference on November 2, 2001, the parties agreed to recommend that the Commission adopt the following procedural schedule in this case:

Wednesday, January 2, 2002	Staff files direct testimony
Friday, January 18, 2002	Company, OPC and intervenors file rebuttal testimony
Friday, January 25, 2002	Parties jointly submit list of issues
Friday, February 1, 2002	Staff files surrebuttal testimony; all other parties file cross- surrebuttal testimony

Friday, February 8, 2002

All parties file statements of positions on issues; parties jointly file list of witness, order of witnesses, and order of cross-examination

Thursday, February 21, 2002 – Friday, February 22, 2002

Evidentiary hearing

WHEREFORE, the parties jointly request that the Commission issue an order adopting the procedural schedule specifically set forth in Paragraph 2 hereof.
