AFFIDAVIT

I, Heath Sellenriek, a natural person, do hereby swear and affirm that I am an officer or authorized representative of (“the Company”), and that the following statements are true and correct to the best of my knowledge and belief.

(1) The Company seeks to change the company’s service area to provide interconnected voice over Internet protocol service. This request adds the following service area(s) as identified by each exchange, in whole or in part, of a local exchange company:

(2) If there has been any changes from the previously filed information, the location of the principal place of business and the names of the principal executive officers of the Company are:

(3) The Company is legally, financially, and technically qualified to provide interconnected voice over Internet protocol services;

(4) The Company is ready, willing, able, and will comply with all applicable state and federal laws and regulations imposed upon providers of interconnected voice over Internet protocol services;

(5) The Company will charge and collect from its end user customers on interconnected voice over Internet protocol service, and remit to the appropriate authority, fees and surcharges in the same manner as are charged and collected upon end user customers of local exchange telecommunications service and remitted by local exchange telecommunications companies, including but not necessarily limited to:

- (a) Telecommunications programs under section 209.255, RSMo;
- (b) Missouri universal service fund under section 392.248;
- (c) Local enhanced 911;
- (d) Any applicable license tax;

(6) The Company will remit the annual assessment imposed by the Commission under section 386.370, RSMo;

(7) The Company will file with the Commission an annual report at a time and covering the yearly period fixed by the Commission; and


(8) The Company has established a process for handling inquiries from customers concerning billing issues, service issues, and other consumer-related complaints. If there have been any changes from the previously filed information, consumer complaints may be directed to:

(9) The Company's interconnected voice over Internet protocol service meets the following criteria:

- (a) Enables real-time, two-way voice communications;
- (b) Requires a broadband connection from the user's location;
- (c) Requires Internet protocol-compatible customer premises equipment; and
- (d) Permits users generally to receive calls that originate on the public switched telephone network and to terminate calls to the public switched telephone network.

(10) By signing this form, I hereby certify that neither I, nor any other member of this filing party, has had communications with a Commissioner, Commission Advisor, Regulatory Law Judge, member of the General Counsel or any member of their support team in the sixty (60) days prior to the filing date of this form regarding any substantive issue included in this filing. If any communication of this sort has occurred in the previous sixty (60) day period, I further certify this application was held until sixty (60) days have passed from the date of the subject communication, or we have requested a waiver for good cause as allowed by Commission Rule 20 CSR 4240-4.017(1)(D).
