will operate as a nonprofit corporation under Chapter 355, RSMo. The new nonprofit water and

sewer company will be named Peaceful Valley Service Company. Upon completion of this

conversion and this Commission's approval, Peaceful Valley Service Company will not be

subject to the jurisdiction of this Commission as provided for under §393.847.2, RSMo.

5. Pursuant to Chapter 393 RSMo, Peaceful Valley Service Company has included in it's

Articles of Conversion language to reflect the elimination of all outstanding stock, change in

membership to persons who receive water and sewer services, and alteration of the water and

sewer company's governance and conduct (see App. B).

6. Peaceful Valley Service Company has no pending actions or final unsatisfied

judgments or decisions against it from any state or federal agency or court which involves

customer service or rates, which action, judgment or decision has occurred within three (3) years

of the date of the Application. No Missouri annual reports or assessment fees are overdue.
