**SECOND ORDER DIRECTING FILING**

On September 21, 2000, Discount Manufactured Housing, Inc. (Respondent) filed with the Missouri Public Service Commission (Commission) a letter report on mediation. Nothing further has been filed since that date. The mediation referral order issued by the Commission on May 25, 2000, stated, *inter alia*, that each party shall advise the Commission in writing of the status of the mediation process by letter no later than the last day of each month beginning on the last day of July of the year 2000.

**IT IS THEREFORE ORDERED:**

1. That the Staff of the Missouri Public Service Commission and Discount Manufactured Housing, Inc. shall, no later than February 8, 2001, advise the Missouri Public Service Commission of the status of the mediation process by letter and then shall adhere to the mediation referral order issued on May 25, 2000.
