**ORDER APPROVING TARIFF**

Kansas City Power & Light Company (KCPL) submitted to the Missouri Public Service Commission revised tariff sheets bearing an effective date of May 10, 1999, designed to allow its Real-Time Pricing to continue beyond its initial three-year pilot. The company requested expedited approval of the proposed tariff sheets because the current Schedule RTP will expire on April 20, 1999.

The Staff of the Missouri Public Service Commission (Staff) reviewed the proposed tariff sheets and filed its recommendation on April 16, 1999. Staff stated that The original Schedule RTP was approved by the Commission on April 20, 1996, as a three-year pilot program. Staff states that the program offers "customers the opportunity to choose between two service options which allow them to grow or reduce load at marginal cost-based prices and to shift load from expensive to lower-cost hours."

Staff stated that expedited treatment is appropriate and that the public interest will be served by the expeditious approval of these tariff sheets.

The Commission has considered KCPL's proposed tariff sheets and Staff's recommendation and determines that the company's proposed tariff sheets are reasonable. The Commission finds that good cause exists for expedited treatment of the tariff sheets. The proposed tariff sheets submitted on April 6, 1999, shall be approved to become effective on April 21, 1999.

**IT IS THEREFORE ORDERED:**

1. That the tariff sheets filed by Kansas City Light & Power Company on April 6, 1999, are approved to become effective on April 21, 1999. The tariff sheets approved are:
