ORDER APPROVING INTEREXCHANGE AND NON-SWITCHED LOCAL EXCHANGE **CERTIFICATES OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF**

Nextlink Missouri, Inc. (NLM) applied to the Public Service Commission on November 16, 1998 for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.410-.450, RSMo 1994, and RSMo Supp. 1997¹. NLM asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. NLM is a Washington corporation, with its principal office located at 500 108th Avenue NE, Suite 2200, Bellevue, WA 98004.

The Commission issued a Notice of Applications and Opportunity to Intervene on November 24, 1998, directing parties wishing to intervene to file their requests by November 9, 1998. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present State ex rel. Rex Deffenderfer Enterprises, Inc. v. Public evidence. Service Commission, 776 S.W.2d 494, 496 (Mo. App. 1989). Since no one

has asked permission to intervene or requested a hearing, the Commission may grant the relief requested based on the verified application.

NLM filed a proposed tariff in conjunction with its application and filed substitute sheets on January 4 and 8, 1999. The tariff's effective date is January 29, 1999. NLM's tariff describes the rates, rules, and regulations it intends to use, identifies NLM as a competitive company, and lists the waivers requested. NLM intends non-switched to provide interexchange and local exchange telecommunications services including 1+ dialing, 800/888/877 services, directory assistance, and operator services.

In its Memorandum filed on January 20, 1999, the Staff of the Commission stated that NLM's proposed services are similar to existing IXC offerings. Staff recommended that the Commission grant NLM a certificate of interexchange service authority. Staff recommended that the Commission grant NLM competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on January 29, 1999.

The Commission finds that competition in the intrastate interexchange and non-switched local exchange telecommunications markets is in the public interest and NLM should be granted certificates of service authority. The Commission finds that the services NLM proposes to offer are competitive and NLM should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered

paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that NLM's proposed tariff details the services, equipment, and pricing it proposes to offer, and is similar to tariffs approved for other Missouri certificated interexchange and non-switched local exchange carriers. The Commission finds that the proposed tariff filed on November 11, 1998 shall be approved as amended to become effective on January 29, 1999.

IT IS THEREFORE ORDERED:

1. That Nextlink Missouri, Inc. is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the State of Missouri, subject to the conditions of certification set out above.

2. That Nextlink Missouri, Inc. is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
