and the Staff states:


1. On August 6, 2001, Environmental Utilities, LLC filed its Application for a Certificate of Convenience and Necessity.
2. On or about August 29, 2001, the Office of the Public Counsel filed a Request for a Hearing, which was opposed by Environmental Utilities.
3. On September 5, 2001, the Commission issued its Order Scheduling A Prehearing Conference And Directing The Parties To File A Procedural Schedule.
4. A Prehearing Conference was held on September 19, 2001, at which time the parties agreed to the following procedural schedule, and the parties unanimously agree to propose the following procedural schedule.

Direct Testimony or Stipulation And Agreement All Parties	October 10, 2001
Rebuttal Testimony All Parties	October 31, 2001
Prehearing Conference	November 5, 2001
Surrebuttal Testimony All Parties	November 14, 2001
Issue List All Parties	November 21, 2001
Position Statements and Order Of Witnesses All Parties	November 28, 2001
Evidentiary Hearing	November 14, 2001


