## **STAFF REPORT AND RECOMMENDATION**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff") and for its report and recommendation states as follows:

- 1. On September 4, 2009 the Staff initiated a prudence audit of the costs subject to The Empire District Electric Company's ("Empire") commission-approved fuel adjustment clause for the period of September 1, 2008 through August 31, 2009.
- 2. On September 9, 2009, Staff filed its Notice of Start of Prudence Audit for that audit.
- 3. Empire's tariff provides that as part of its fuel adjustment clause there "shall be prudence reviews of costs" and that "[p]rudence reviews shall occur no less frequently than at 18 month intervals." This tracks the language of both Commission Rule 4 CSR 240-20.090(7) and § 386.266.4(4) RSMo Supp 2009.
- 4. In its last general rate case, Case No. ER-2008-0093, the Commission approved Empire's original fuel adjustment clause tariff sheets numbered 17, 17a, 17b and 17c to become effective on September 1, 2008.<sup>2</sup> Tariff sheet number 17 provides for

recurring six-month accumulation periods of September-to-February and March-to-August.

- 5. The Staff has conducted a prudence review of the costs associated with Empire's fuel adjustment clause for an audit period of September 1, 2008 through August 31, 2009.<sup>3</sup>
- 6. Rule 4 CSR 240-20.090(7)(B) establishes the following schedule of dates by which certain events are to take place, keyed off of the date the Staff initiates its prudence audit:
