**REPLY TO ROLLA’S REPLY TO RESPONSES OF OTHER PARTIES**

1. Comes now Donna Hawley of 2602 Brook Dr., Rolla, Mo to respond to Rolla Municipal Utilities (RMU) reply to responses of other parties submitted on August 3, 2010.

2. The standard for a party’s data requests and evidence before the Commission is the same as that of litigants in civil action before the Circuit Courts of Missouri. **4 CSR 240-2.090 (1)**. Failure to provide a pro se party with the same access to evidence, documents and data as every other party before the Commission or in Circuit Courts would be extremely prejudicial against the pro se party. The object of hearings before the Commission is to provide a fair and unbiased hearing. RMU’s insistence on granting me less access to pertinent data would most likely guarantee a biased outcome in their favor. Additionally, in this instance and under the circumstances which occurred in March 2009, it would be unreasonable to require that I sit in an RMU office to take notes of closed material included the Study. Therefore I ask that the Commission deny RMU’s request 12(b) in their original Motion filed on August 2, 2010.

3. Unless RMU has closed data in the RW Beck engineering study (the Study) which is as illegal as the discriminatory remarks made during executive session of the Rolla City Council simply because members and co-leaders (Tracey Watson and myself) of the RMU4YOU! group exercised their right to petition the government and express their opinions, then RMU is again showing paranoia that I would make public any closed sections of the Study. Surely RMU is aware that the Missouri Sunshine Law exemptions do not protect the illegal activities of any governmental body during executive session, nor does it place a gag order on any meeting participant who chooses to disclose the illegal activity.
