**ORDER APPROVING TARIFF FILED IN  
COMPLIANCE WITH COMMISSION ORDER**

On February 29, 2000, the Commission issued its Order Directing Rate Reduction directing Union Electric Company d/b/a AmerenUE (AmerenUE) to file tariff sheets with the Commission to implement the permanent rate reduction in the amount of \$16,321,000, as agreed in Case No. EO-96-15 and EM-96-149.

On March 23, 2000, AmerenUE filed its proposed tariffs, P.S.C. MO. Schedule No. 5 in Tariff File No. 20000865. The Commission ordered the proposed tariff sheets to be filed with an effective date of April 1, 2000. AmerenUE filed the proposed tariff sheets with the effective date of March 30, 2000, instead of April 1, 2000, and recommended the Commission approve the tariffs with the earlier effective date because March 30, 2000 is the first scheduled meter reading date of AmerenUE's April billing month.

The Commission's Staff reviewed the tariff sheets and filed a memorandum on March 29, 2000, recommending that the Commission approve AmerenUE's tariff sheets with the proposed earlier effective date of March 30, 2000. Staff noted that substitute pages will have to be filed for the summer rates in the proposed tariff sheets in order for them to be consistent with the instructions given in Cole County Circuit Court case number 00CV323273cc, on March 28, 2000.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets, with the earlier effective date of March 30, 2000, conform to the Commission's order issued February 29, 2000 and should be approved to become effective on March 30, 2000.

**IT IS THEREFORE ORDERED:**

1. That the tariff, Tariff File No. 200000865, submitted in File Nos. EO-96-15 and EM-96-149, by Union Electric Company d/b/a AmerenUE on March 23, 2000, is approved to become effective on March 30, 2000. The tariff approved is:


