ORDER DIRECTING FILING

On October 25, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a Motion to Compel discovery. Staff's motion included copies of the Data Requests (DRs) at issue in Attachment 1. Staff stated that it received a letter from AmerenUE objecting to these DRs in a letter dated October 3, 2000, which Staff received on October 4, 2000, but Staff did not provide a copy of that response to the data requests containing the written objections. Staff's motion also stated that Staff received a second letter from AmerenUE respecting certain DRs, but Staff does not state the date of that letter and does not provide a copy of that letter containing the written objections. The Commission will direct Staff to file a copy of documents containing the written objections of AmerenUE.

IT IS THEREFORE ORDERED:

1. That Staff of the Missouri Public Service Commission is directed to file a copy of documents containing the written objections of AmerenUE no later than 12 p.m. on October 30, 2000.

2. That this order shall become effective on October 30, 2000.
