ORDER APPROVING TARIFFS PURSUANT TO COMMISSION ORDER

On November 17, 2000, Southern Missouri Gas Company, L.P. (SMG) submitted tariff sheets pursuant to an Order Approving Stipulation and Agreement issued November 16, 2000. SMG, at the request of the Staff of the Commission (Staff), submitted substitute sheets on November 28, 2000. SMG requested approval on less than 30 days' notice in order to implement the new rates at the beginning of a billing cycle.

On November 28, 2000, Staff filed its memorandum in which it states that it has reviewed the tariffs, finds that they are correct and comply with the Commission's order, and recommends approval.

The Commission has reviewed the tariff filing and the Staff memorandum and has determined the filing to be in compliance with the Commission's order. The Commission further finds that SMG has demonstrated good cause for approval of the tariff sheets on less than 30 days' notice.

IT IS THEREFORE ORDERED:


