ORDER AND NOTICE

Section 9, Township 21 North, Range 31 West. The proposed pipeline will be installed within a private right of way and adjacent to existing county roads and state highway right of way.

The Commission has determined that the Records Department of the Commission shall mail a copy of this order to each of the eleven residents and/or landowners within the proposed service area as shown on Appendix E which is attached to the application. The Records Department of the Commission shall also mail a copy of this order to the County Commission of McDonald County, Missouri. In addition, the Information Officer of the Commission shall send a notice of this application of each newspaper located in McDonald County, Missouri, as listed in the newspaper directory of the current *Official Manual of the State of Missouri*, and to all members of the General Assembly representing McDonald County, Missouri.

The Commission also determines that proper parties shall be given the opportunity to intervene in this case. Applications to intervene shall be filed with the Executive Secretary of the Missouri Public Service Commission, Post Office Box 360, Jefferson City, Missouri 65102, on or before January 30, 1995. Commission may determine that a hearing is not necessary and that the Applicant may submit its evidence in support of the application by verified statement. *State ex Rel. Deffenderfer Enterprises, Inc. v. P.S.C.*, 776 S.W.2d 494, 496 (Mo. App. 1989).

IT IS THEREFORE ORDERED:

1. That the Records Department of the Missouri Public Service Commission is ordered to provide notice as set out herein.
2. That the Information Officer of the Missouri Public Service Commission is ordered to provide notice as set out herein.
3. That any proper party wishing to intervene in this matter shall file an application to do so no later than January 30, 1995. Such applications shall be filed with the Executive Secretary of the Missouri Public Service Commission, Post Office Box 360, Jefferson City, Missouri.
4. That this order shall become effective on the date hereof.
