ORDER APPROVING TARIFF

On November 15, 1994, Dan Dowell, receiver for Davis Water Company (Davis), submitted a request to increase rates for water service pursuant to the Commission's informal rate case procedures in 4 CSR 240-2.060(8). The Commission ultimately issued an Order Approving Rate Increase on May 19, 1995. As part of its order, the Commission ordered Mr. Dowell, as receiver for Davis, to file a 30-day tariff to change the Environmental Improvement and Energy Resources Authority (EIERA) surcharge from \$4.67 to \$4.23.

On June 19, 1995, the Staff of the Commission (Staff) filed a memorandum recommending approval of the tariff sheet filed by Davis. Staff indicates that Davis filed a tariff sheet with the ordered change in the EIERA surcharge on May 31, 1995, with an effective date of July 1, 1995. Staff notes that the reduction from \$4.67 to \$4.23 per month reflects an increase in customers. Staff states that it has reviewed the tariff sheet filed by Davis on May 31, 1995, and recommends that it be approved for water service rendered on and after July 1, 1995. In addition, Staff states that this filing will have no effect on any other matter for the company that may be pending before the Commission at this time.

The Commission finds that Staff's recommendation is appropriate, and that the tariff sheet filed by Davis complies with the Commission's Order Approving Rate Increase issued on May 19, 1995. The

Commission also finds that the rate contained in the tariff sheet is just and reasonable. Thus, the Commission approves the tariff sheet filed by Davis on May 31, 1995.

IT IS THEREFORE ORDERED:


