ORDER APPROVING TARIFF

On June 29, 1994, Sprint Communications Company L.P. (Sprint) submitted a proposed tariff to establish two promotions and requested expedited approval by July 15, 1994. The first promotion, entitled "We'll Split It With You," will offer new subscribers to Option A, and existing subscribers to Option A who request it, a 50 percent discount off calls to the subscriber's most frequently called number in lieu of the normal 20 percent discount. The 50 percent discount will apply for three billing periods after the establishment of service or after the subscriber's request, and the promotion will expire September 18, 1994. It may not be used in conjunction with any other promotion.

The second promotion, entitled "Sprint Service Promotion" will offer new and existing Message Telecommunication Service (MTS) SPRINT Service customers who enroll in this promotion a discount off their combined interstate and intrastate SPRINT service, FONCARDSM, and Operator Service usage and surcharges. The promotion provides a discount of 20 percent for a combined monthly usage of between \$30 and \$74.99, a 30 percent discount for a combined monthly usage of between \$75 to \$149.99, and a 35 percent discount for a combined monthly usage over \$150. The promotion is not available to customers already enrolled in Calling Plans associated with MTS or SPRINT service, and the promotion will expire January 13, 1995. It may not be used in combination with any other promotion.

The Commission's Staff filed its recommendation on July 1, 1994, stating therein that the Staff has no objections to the proposed promotional tariff filing, and therefore recommends approval of the proposed tariff filing on an expedited basis with an effective date of July 15, 1994. Staff also indicates that it unaware of any other filings which would affect or be affected by this proposal.

The Commission finds that the Staff's recommendation is appropriate, and that the tariff filing is just and reasonable. The Commission is also of the opinion that expedited treatment should be given to the tariff filing in order to provide as much customer benefit as possible from these two promotional offerings.

IT IS THEREFORE ORDERED:

1. That the following tariff sheet filed by Sprint Communications Company L.P. on June 29, 1994 be and is hereby approved to become effective July 15, 1994:

2. That this Order shall become effective on July 15, 1994.
