ORDER APPROVING TARIFFS PURSUANT TO COMMISSION ORDER

On July 3, 1996, the Commission issued its order approving a stipulation and agreement. As part of that order, the Commission approved proposed tariffs, to be filed for service on or after July 9, 1996.

On December 4, 1996, Kansas City Power and Light Company (KCPL or Company) of Kansas City, Missouri, filed tariff sheets to comply with the Missouri Public Service Commission's (Commission's) Order Approving Stipulation and Agreement (Order) dated July 3, 1996, in Case No. EO-94-199. On December 12, 1996, KCPL filed two substitute tariff sheets correcting minor typographical errors. The filed tariff sheets are designed to implement Phase II of the Stipulation and Agreement previously filed in Case No. EO-94-199 in which KCPL's revenues are to be reduced by approximately \$11 million. KCPL previously filed, and the Commission approved, Phase I tariff sheets resulting in a revenue reduction of approximately \$9 million.

On December 18, 1996, the Staff of the Commission (Staff) filed its recommendation. The Staff reviewed the filed Phase II tariff sheets and is of the opinion that they comply with the Commission's Order issued July 3, 1996. Staff recommended that the tariff sheets, as filed by the Company on December 4, 1996, and as substituted on December 12, 1996, be approved, to become effective for service rendered on and after January 1, 1997.

The Commission has reviewed the proposed tariffs and Staff recommendation. The Commission finds the proposed tariffs to be reasonable and in compliance with the Commission's order in that case and will, therefore, approve the tariffs for service on or after January 1, 1997.

IT IS THEREFORE ORDERED:


