### **ORDER GRANTING EXTENSION OF TIME**

On March 13, 1997, the Staff of the Public Service Commission (Staff) filed a Motion For Extension Of Time in this case. The parties to this case had previously been ordered to submit either a stipulation and agreement or a procedural schedule to the Commission no later than March 14. The Staff states in its motion that as a result of the prehearing conference and subsequent negotiations, a preliminary stipulation and agreement has been reached among the parties. The parties anticipate that a unanimous stipulation and agreement can be completed and filed by March 21, 1997.

Because the request was not filed until the day before the deadline, an order could not be issued prior to the deadline. Staff's motion shall be granted for good cause shown.

#### IT IS THEREFORE ORDERED:

1. That the filing deadline for either a stipulation and agreement or a procedural schedule shall be moved from March 14, 1997 to March 21, 1997.

2. That this order shall become effective on the date hereof.
