# ORDER SCHEDULING SECOND DAY OF HEARING

The Commission convened a hearing on January 7, 2002, regarding Environmental Utilities, LLC's application for a certificate of authority to construct and operate a water system in a subdivision in Camden County, Missouri. The hearing was not completed on January 7, and the Commission will schedule a continuation of that hearing.

At the hearing, the presiding officer requested that counsel for the parties inform him of the dates for which they would not be able to appear for the completion of the hearing. Staff, the Office of the Public Counsel, and Environmental Utilities submitted exclusionary dates. Hancock Construction did not submit exclusionary dates, so the Commission will assume that counsel for Hancock Construction has no exclusionary dates.

After reviewing its calendar, the Commission finds that it has no available hearing dates until March 4, 2002. No party has indicated its unavailability for that date, so it will be used for the continuation of this hearing.



#### IT IS THEREFORE ORDERED:

- 1. That the hearing in this case shall reconvene on March 4, 2002, beginning at 8:30 a.m. The hearing shall be held at the Commission's offices at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. This hearing will be held in a building that meets accessibility standards required by the Americans with Disabilities Act.
