ORDER SUSPENDING PROCEDURAL SCHEDULE AND DIRECTING FILING

On September 26, 2001, the Staff of the Missouri Public Service Commission, on behalf of all of the parties, moved the Commission to cancel the procedural schedule and stay further proceedings herein because of certain issues raised by the United States Department of Agriculture regarding the proposed territorial agreement. The parties did not specify the nature of those issues and, indeed, may not have that information. The parties pray that the Commission will cancel the procedural schedule and stay the proceedings until such time as the U.S.D.A. approves the proposed territorial agreement.

The Commission notes that, since the motion was filed, the parties have failed to comply with the Procedural Schedule adopted by the Commission on September 7, despite the fact that the Commission had not yet ruled on the motion. Thus, it is not now possible to convene a hearing on October 15. Therefore, the Commission will suspend the procedural schedule and cancel the hearing.

Section 247.172.3, RSMo 2000, requires that the Commission act on a proposed territorial agreement within 120 days, unless the Commission extends the period for good

cause shown. It is this authority that the parties urge the Commission to exercise. However, the parties have not shown good cause such as would justify an extension of the statutory deadline. The vague explanation that the U.S.D.A. has raised "issues" does not constitute good cause.

The Commission will direct the parties to submit an amended procedural schedule that will complete this case within the statutory 120-day timeline. Any request for an extension of that timeline must be supported by allegations of fact and law making out good cause such as would support such an extension.

IT IS THEREFORE ORDERED:

- That the Joint Motion to Cancel Procedural Schedule and Stay Proceedings, filed by the Staff of the Missouri Public Service Commission on behalf of all parties on September 26, 2001, is denied.
 - 2. That the hearing set for October 15, 2001, is canceled.
 - 3. That the procedural schedule adopted on September 7, 2001, is suspended.
- 4. That the parties shall, on or before October 19, 2001, submit a proposed amended procedural schedule that complies with Section 247.172.3, RSMo 2000.

5. That this order shall be effective on October 11, 2001.
