**ORDER GRANTING LEAVE TO FILE ANNUAL REPORT OUT OF TIME**

Pursuant to 4 CSR 240-10.080(1), "[a]ll public utilities subject to the jurisdiction of the Missouri Public Service Commission shall file an annual report with the commission on or before April 15 of each year."

On June 15, 2000, Omni Call, Inc. (Omni Call), filed a motion with the Commission requesting permission to file its 1999 annual report out of time. Omni Call included its 1999 annual report with its motion. Omni Call stated in its motion that it attempted to file its annual report in a timely manner, but "either because of delays in the United States Mail or because of inadvertent internal difficulties" the report was not received by the Commission until after the April 15 deadline. No objections to Omni Call's motion were received.

The Commission finds that good cause exists to permit filing of Omni Call's annual report out of time, and the Commission will grant Omni Call's motion for leave to file its annual report out of time.

**IT IS THEREFORE ORDERED:**

1. That Omni Call, Inc.'s June 15, 2000, motion requesting permission to file its annual report out of time is granted.

2. That the annual report deadline requirement of 4 CSR 240-10.080 is waived and the filing of Omni Call, Inc.'s annual report on June 15, 2000, is approved.

3. That this order shall become effective on July 7, 2000.

4. That this case may be closed on July 10, 2000.
