ORDER APPROVING TARIFF

On December 2, 1999, the Commission issued an Order Granting Certificate of Service Authority to Provide Basic Local Exchange Telecommunications Services to Fidelity Communication Services I, Inc. (FCS I). FCS I's certificate of service authority was to become effective upon the effective date of its approved tariffs. Pursuant to that order, FCS I filed a letter requesting an extension to file its tariff sheets from February 20, 2000, to April 14, 2000. FCS I indicated that the General Counsel's Office did not object to the extension. On April 3, 2000, FCS I filed tariff sheets with an effective date of June 1, 2000. FCS I filed substitute sheets on May 9, 2000.

On May 10, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a memorandum recommending that the Commission grant approval of FCS I's basic local exchange tariff, as amended, to become effective June 1, 2000. Staff states that it has determined that the tariff conforms to the Commission's standards and that it covers the provisions of resold and facilities-based intrastate telecommunications

services. FCS I's tariff reflects that Rolla is the only exchange that the applicant proposes to serve at this time. The tariff contains a list of the approved waivers listed in the order granting certification. Staff also indicates that the tariff is similar to other competitive local exchange company tariffs previously approved by the Commission.

The Commission has reviewed the proposed tariff sheets and staff's recommendation, and finds that the tariff sheets, as amended, conform to the Commission's order of December 2, 1999. The Commission determines that the tariff sheets, as amended, should be approved to become effective on June 1, 2000.

IT IS THEREFORE ORDERED:

1. That the proposed tariff sheets filed on April 3, 2000, by Fidelity Communication Services I, Inc., and amended on May 9, 2000, are approved to become effective on June 1, 2000. The specific tariff sheets approved are as follows:
