COMMISSION ORDER

The Commission granted Union Electric Company d/b/a AmerenUE (AmerenUE) and Lewis County Rural Electric Cooperative's (Lewis County) joint application for approval of a written territorial agreement on July 21, 2000. The order directed AmerenUE to file revised tariff sheets consistent with the territorial agreement. AmerenUE filed the required tariff sheets on August 15, 2000. On September 1, 2000, AmerenUE filed substitute sheets.

The Staff of the Missouri Public Service Commission (Staff) reviewed the tariff sheets and filed a memorandum on August 31, 2000, recommending that the Commission approve the tariffs as filed on August 15, 2000, and substituted on September 1, 2000. Staff stated that the tariff sheets comply with the Commission's Report and Order and should be approved to become effective on September 14, 2000.

Having reviewed the tariff sheets and the Staff's recommendation, the Commission finds that the tariff sheets conform to

the Commission's order and should be approved to become effective as ordered below.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by Union Electric Company d/b/a AmerenUE on August 15, 2000, are approved as amended to become effective on September 14, 2000. The tariff sheets approved are:
