ORDER APPROVING TARIFF IN COMPLIANCE WITH COMMISSION ORDER

The Commission issued an order approving the Amended Stipulation and Agreement of the parties on August 1, 2000. That order also directed Missouri Gas Energy (MGE) to file tariffs in compliance with the Commission's order no later than 30 days after the effective date of the order. MGE filed tariffs on August 7, 2000, and filed a substitute tariff sheet on August 10, 2000. The proposed effective date of the tariff is September 6, 2000.

The Staff of the Missouri Public Service Commission (Staff) reviewed the tariff sheets and filed a recommendation on August 15, 2000. Staff stated that in its opinion, MGE has complied with the Commission's order and that the tariffs filed are substantially similar to those filed as illustrative tariffs and as agreed to by the parties. Staff stated that it has no objection to the Commission approving MGE's tariff sheets as amended.

In addition, MGE requested in its cover letter filed with the tariffs that the Commission expedite its approval of these tariff sheets. However, MGE did not file a motion to expedite in compliance with Commission rule 4 CSR 240-2.080(17). Staff indicated that it

believes good cause exists, given the uncertainty and volatility of the natural gas market at the present time, to approve these tariff sheets on less than 30 days notice. Neither MGE nor Staff stated a date by when the tariffs should become effective.

The Commission has reviewed MGE's proposed tariff and Staff's recommendation and finds that the tariff is in compliance with the Commission's order. In addition the Commission finds good cause in accordance with Section 393.140(11), RSMo 1994, to approve this tariff to become effective on less than 30 days notice. The Commission finds that the proposed tariff should be approved as amended to become effective as ordered below.

IT IS THEREFORE ORDERED:

1. That the tariff filed by Missouri Gas Energy, on August 7, 2000, Tariff No. 200100119, is approved as amended to become effective on August 31, 2000. The tariff approved is:
