**STAFF REPORT AND MOTION FOR PROTECTIVE ORDER**

Comes now the Staff of the Missouri Public Service Commission (Staff), pursuant to a September 12, 2005 *Order Directing Staff To Investigate And File A Report* of the Missouri Public Service Commission (Commission) and Commission Rules 4 CSR 240-2.085 and 4 CSR 240-2.070(10), submits its Staff Report of its investigation as a “Highly Confidential” document, and requests that the Commission issue a Protective Order in this case.

1. The Staff Report (Appendix A with attached Schedule 1) contains specific billing information and customer account amounts that are asserted to relate directly to the Complainant. Because the Highly Confidential designation of the Commission’s Standard Protective Order may include “material or documents that contain information relating directly to specific customers”, the Staff requests that pursuant to Commission Rule 4 CSR 240-2.085, the Commission issue its standard Protective Order to cover the Staff Report which is being filed as a “Highly Confidential” document. The Staff also makes this request pursuant to 4 CSR 240-2.070(10) which states: “The investigative report shall not be made public unless released in

accordance with Sections 386.480, 392.210(2) or 393.140(3), RSMo, or during the course of the hearing involving the complaint.”

2. The Staff believes that based on the information provided by the Complainant and AmerenUE, there appear to be no violations of any Commission rule and that AmerenUE has acted in accordance with its tariff. This conclusion is consistent with the determination of the Commission’s Consumer Services Department in the informal phase of this Complaint. Therefore, the Staff recommends that the Commission dismiss this complaint case.

Wherefore, the Staff submits its Staff Report respecting its investigation, pursuant to a September 12, 2005 Commission *Order Directing Staff To Investigate And File A Report*, and requests that the Commission issue its standard Protective Order in this case to cover the Staff Report, which is being filed as a Highly Confidential document, and dismiss this complaint case for the reasons stated in Staff’s Report (attached as Exhibit A).
