**ORDER EXTENDING DEADLINE FOR FILING OF CHANGE OF NAME**

This order extends the deadline for Claricom Networks, Inc. to file a change of name.

On December 13, 2001, the Commission issued its first order directing the filing of a change of name by March 1, 2002. On March 1, 2002, Claricom Networks, Inc. filed a pleading, stating that it needed more time to comply with the December 13, 2001 order of the Commission; preferably until August 1, 2002.

In order to give Claricom enough time to comply with the order, the Commission will extend the deadline to September 3, 2002.

**IT IS THEREFORE ORDERED:**

1. That Claricom Networks, Inc. must file no later than September 3, 2002, a pleading complying with the order directing the filing of a change of name issued by the Missouri Public Service Commission on December 13, 2001.

2. That this order will become effective on March 14, 2002.
