

ORDER APPROVING TARIFF SHEETS

By its Order Approving Stipulation and Agreement dated May 20, 1987 in these cases, this Commission authorized Laclede Gas Company to file revised tariffs designed to decrease jurisdictional gross annual gas revenues by \$7 million exclusive of applicable license, occupation, franchise, gross receipts or other similar fees or taxes.

On May 22, 1987, Laclede Gas Company submitted revised tariff sheets for Commission review and approval, to comply with the Commission's May 20, 1987, Order.

The Commission is of the opinion the revised tariffs submitted May 22, 1987 by Laclede Gas Company comply with its Order Approving Stipulation and Agreement dated May 20, 1987, and said tariff sheets should be allowed to become effective for service rendered on and after July 1, 1987.

It is, therefore,

ORDERED: 1. That the following tariff sheets submitted May 22, 1987, by Laclede Gas Company for the purpose of decreasing rates for gas service provided to customers in its Missouri service area be, and they are, hereby approved and made effective for service rendered on and after July 1, 1987.
