On July 16, 2018, TracFone Wireless, Inc. ("TracFone") filed a request to provide Lifeline Service through additional brands. This request, if granted, would modify the Missouri Public Service Commission's prior order designating TracFone as an eligible telecommunications carrier for Lifeline support in Missouri only under the registered fictitious name SafeLink Wireless. The Commission will issue notice, set a deadline for intervention requests, and direct the filing of a recommendation by the Staff of the Commission.
