REPORT AND ORDER

Procedural History

On September 29, 1989, West Elm Place Corporation (Applicant or WEPC) applied under Section 393.170 RSMo 1986 for a certificate of public convenience and necessity to provide regulated sewer service in Jefferson County, Missouri. Applicant previously received certificates in Cases 16,489 and 17,456 and now requests authority to provide sewer service in a 1080 acre tract adjacent to Applicant's previously certificated area.

On October 17, 1989, the Commission issued an Order and Notice which

(a) notified elected and appointed officials of Applicant's proposal; (b) required

notice of said application to be published in area newspapers; (c) provided notice to

ten individuals who were then receiving sewer service, and (d) established an

intervention deadline of November 16, 1989. A request for hearing filed on November

8, 1989 by Carole A. Matt was subsequently withdrawn.

On December 11, 1990, the Commission, noting the long pendency of the application, ordered a hearing in this matter. On November 11, 1991, the Commission granted a motion by the Applicant to suspend the hearing, stating that Applicant was

Findings of Fact

Having considered all the competent and substantial evidence upon the whole S. Sink record, the Missouri Public Service Commission makes the following findings of fact: # F 1, 10 1 4 1 m. m

Applicant West Elm Place Corporation is a Missouri corporation duly organized and existing under the laws of the State of Missouri with its principal * . 带艺 藝 。 5 office and place of business at P.O. Box 456, Arnold, Missouri. Applicant has been under the Commission's jurisdiction since 1969, and holds certificates of convenience and necessity to operate a sewer system granted in Case Nos. 16,489 and 17,456.

On April 12, 1991, the Commission Staff filed a memorandum recommending the approval, subject to conditions, of this Application. Staff states, and the Commission finds, that a need for sewer service in the 1080 acre tract adjacent to Applicant's presently certificated area exists, and that it is in the public interest to grant WEPC a certificate. The 1080 acre tract is in the process of being developed for residential housing. The Staff also recommends, and the Commission finds, that Applicant is qualified to serve the area and may undertake service on the following conditions:

- (1) That all service under this certificate be provided under Applicant's existing rates, rules and regulations.
- That within 30 days of the effective date of this order, WEPC amend its tariff by filing a revised map and metes and bounds description to reflect those changes in its proposed service area which are contained in Applicant's revised feasibility study.

The Commission finds that Staff's recommendations are reasonable and hereby adopts same; the Commission also finds that it is reasonable to apply the rates, charges and conditions in Applicant's present tariff to service in Applicant's newly certificated area herein granted.

The Commission also finds that Applicant is qualified and financially able to operate the sewer system described in its Application and further concludes that there is a present and future need for sewer service in the proposed service area and that providing same is necessary and convenient to the public.

Conclusions of Law

The Missouri Public Service Commission has arrived at the following conclusions of law:

The Commission has jurisdiction over this application by virtue of Sections 393.170 and 393.150, RSMo 1986.

The Commission concludes that the proposed rates are reasonable and that a hearing is not required in this matter. State ex rel. Deffenderfer Enterprises, Inc. v. PSC, 776 S.W.2d 494, 496 (Mo. App. 1989).

IT IS THEREFORE ORDERED:
