- 2. The Staff has examined the tariff filing and believes that it complies with the Commission's Report and Order, which was issued on August 31, 2000 and became effective on September 14, 2000, and with the Order of Clarification, which was issued on September 14, 2000 and becomes effective on September 22, 2000.
- 3. The Staff further believes that the Company's request for approval of the subject tariff sheets on less than 30 days notice is reasonable and appropriate, and that good cause exists for the Commission to grant the Company's Motion for Expedited Treatment.

WHEREFORE, The Staff recommends that the Commission issue an order approving the Company's tariff sheets, as identified herein, on an expedited basis, for service rendered on and after September 20, 2000.

with the Commission's Report and Order and Order of Clarification

On August 31, 2000, the Missouri Public Service Commission (Commission) issued a *Report and* Order (Order), in which it authorized water service rate changes for the Missouri-American Water Company ("Company") pursuant to its decisions in the Company's general rate case, Case No. WR-2000-281. As a part of its Order, the Commission authorized the Company to file revised tariff sheets consistent with the Order. On September 14, 2000, the Commission clarified its Order with the issuance of an *Order of Clarification* (Clarification).

On September 15, 2000, the Company filed revised tariff sheets intended to be in compliance with the Commission's Order and its Clarification issued in this case. The revised tariff sheets bore an issue date of September 15, 2000 and an effective date of October 15, 2000. However, as noted in its Motion for Expedited Treatment and Approval of Tariff Sheets that was also filed on September 15, the Company has requested that the subject revised tariff sheets be approved as soon as possible on less than 30 days notice.

The Company stated that it believes good cause exists for the expedited approval of the subject tariff sheets since such tariffs are in compliance with the Commission's Order and Clarification wherein the Commission determined that the Company is experiencing a significant revenue deficiency, and since such tariffs are beyond "the operation of law date" for the Company's general rate proceeding.

Also, on September 18, 2000, the Company submitted a substitute sheet for a sheet of the September 15, 2000 filing. This substitute sheet was necessary to correct a typographical error.

The Staff has reviewed the revised tariff sheets that the Company filed on September 15, 2000, and the substitute revised tariff sheet that the Company submitted on September 18, 2000, and believes they are in compliance with the Commission's Order and the Commission's Clarification. Additionally, the Staff believes that the Company's request for approval of the subject tariff sheets

on less than 30 days notice is reasonable and appropriate. As a result, the Staff believes that good cause exists for the Commission to grant the Company's motion for expedited treatment and approval pursuant to Section 393.140(11), RSMo 1994.

Based upon the above, the Staff recommends that the Commission issue an Order approving the subject revised tariff sheets, on an expedited basis, to be effective for service rendered on and after September 20, 2000.
