**RE: Missouri RSA 5 Partnership a/k/a Missouri RSA No. 5 Partnership
Relinquishment of ETC Designation, effective December 31, 2021**

To the Missouri Public Service Commission:

Missouri RSA 5 Partnership a/k/a Missouri RSA No. 5 Partnership d/b/a Chariton Valley Wireless Services ("MO5"), in compliance with federal law, including 47 U.S.C. §214(e)(4) and 47 C.F.R. §54.205, and Missouri regulations, including 20 CSR 4240-31.015(4), hereby notifies the Missouri Public Service Commission (the "Commission") that MO5 relinquishes its designation as an eligible telecommunications carrier ("ETC") in Missouri, effective December 31, 2021. The Commission designated MO5 as an ETC in Case No. TO-2006-0172, with an effective date of October 1, 2006.

Numerous other ETCs will continue to serve the area in which MO5 currently is an ETC including numerous other providers of mobile Lifeline service in Missouri. *See, e.g.,* Attachment I. MO5 has provided notice to its current Lifeline customers that they will no longer receive discounted Lifeline services from MO5 after December 31, 2021, and MO5 will provide guidance on how its Lifeline customers can obtain discounted Lifeline services from another provider. Attachment II sets forth the text messages that MO5's Lifeline customers have or will receive, along with information that will be posted to MO5's website.
