**SOCKET TELECOM, LLC'S REPLY TO  
STAFF'S RESPONSE REGARDING AMENDED APPLICATION**

COMES NOW Socket Telecom, LLC ("Socket"), by its undersigned counsel, and pursuant to 4 CSR 240-2.080(15), hereby replies to Staff's response regarding waiver of 4 CSR 240-32.050(4)(B), as follows:

1. Socket will advise its customers in the metropolitan calling areas (MCAs) that they will not receive printed residential white page directories unless they call Socket's toll-free number or use Socket's website to request delivery of such printed directories. Socket will forward to AT&T electronic files identifying those customers that make such requests, so that delivery can be accomplished pursuant to the applicable interconnection agreement.

2. Accordingly, Socket is simply seeking the same limited waiver of 4 CSR 240-32.050(4)(B) as the Commission has granted to its competitors.

WHEREFORE, Socket Telecom, LLC respectfully requests that in addition to the requests contained in its Application to Expand Certificate of Basic Local Service Authority filed in this proceeding that the Commission further grant Socket a waiver of rule 4 CSR 240-32.050(4)(B) to the extent it granted such waiver in File No. IE-2009-0357, and grant such other and further relief to Socket as the Commission deems meet and proper.
