AND MOTION TO ACCEPT COUNTY LISTING OUT OF TIME


Come Now Quick-Tel Communications, Inc. and Affordaphone, Inc., (Applicants herein), by their undersigned counsel and for their Supplement to Application submit the attached: 1) List of Missouri counties in which Quick-Tel operates, 2) Late-filed Officer's Verifications, and 3) Customer Notice. Joint Applicants also move the Commission to accept Quick-Tel's County Listing out of time.

1. County Listing: The Commission's July 2, 2002, ORDER DIRECTING NOTICE AND ORDER DIRECTING FILING instructed Quick -Tel Communications, Inc., and Affordaphone, Inc., to "file a supplement to their application, giving the county or other political subdivision where Quick -Tel Communications, Inc. operates" by July 9, 2002. County information is not routinely maintained by Quick-Tel Communications and had to be researched and prepared manually by the Company. This resulted in a delay in providing the county listing. Quick-Tel apologizes for the lateness in submitting this information, and it is being provided at the earliest time possible. The County Listing is filed herewith as Attachment A, and Joint Applicants move the Commission to accept the County Listing out of time.

2. Verifications: The Verifications page attached as the last page of the Joint Application filed herein on June 26, 2002, indicated the Verifications were "To be Late-Filed". The verifications of officers of the Joint Applicants are being filed at the earliest opportunity and are attached hereto as Attachment B.

3. Customer Notice: The Commission's July 2, 2002, ORDER DIRECTING NOTICE AND ORDER DIRECTING FILING also required notice to customers prior to the transaction and provided that "Quick -Tel Communications, Inc., must file a copy of the written customer notice at least ten days before it is issued to customers, indicating when the notice is scheduled to be issued and the manner in which the customer notice will be served". Customers will be notified of this transaction by bill insert to be mailed with August customer bills, which will be mailed on August 6, August 13, August 22 and August 29. A copy of the Customer Notice is filed herewith as Attachment C.

WHEREFORE, Quick-Tel Communications, Inc., and Affordaphone, Inc., submit this Supplement to Joint Application, move the Commission to accept the County Listing out of time, and request that the Commission grant the relief requested in their now-complete Joint Application for approval of Affordaphone's acquisition of the customers of Quick-Tel.


