## ORDER ALLOWING PARTICIPATION BY TELEPHONE

The Missouri Public Service Commission is granting the motion of Nexus Communications, Inc., dba TSI ("Nexus") to participate by telephone ("the motion") at the on-the-record presentation scheduled in this action, and in file no. TA-2009-0327. The Commission issued an order scheduling the on-the-record presentation on June 12, 2009. On June 22, 2009, Nexus filed the motion.<sup>1</sup> The Commission's staff filed its response on June 23, 2009. The Commission will grant the motion and will also allow telephone participation for TracFone Wireless, Inc.

### THE COMMISSION ORDERS THAT:

1. The motion of Nexus Communications, Inc., dba TSI ("Nexus") to participate by telephone is granted.
2. TracFone Wireless, Inc., may also participate by telephone.

3. The regulatory law judges (“RLJs”) assigned to these files shall convene an on-the-record presentation on July 7, 2009, beginning at 10:00 a.m. by initiating a telephone conference call from Room 310 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri.

4. Any person participating by telephone in the on-the-record presentation described in ordered paragraph 3 shall call:

- a. For persons outside Jefferson City, Missouri: 866-630-9346.
- b. For persons in Jefferson City, Missouri: 526-5402.

Counsel for the Commission’s staff shall attend in person. Any other party or counsel for such party may also attend in person.

5. This order shall become effective upon issuance.
