Dear Ms. Dale:

On behalf of Aquila, Inc. ("Aquila" or "Company"), I am providing herewith to the Missouri Public Service Commission ("Commission") for filing in electronic form certain tariff sheets consisting of revised electric rate schedules which are designed to increase the annual electric revenue of the Company's Aquila Networks - MPS operating division by approximately \$94.5 million and the annual electric revenue of the Company's Aquila Networks - L&P operating division by approximately \$24.4 million, all exclusive of applicable franchise and occupational taxes. The rate schedules bear a date of issue of July 3, 2006, and an effective date of August 2, 2006.

Also provided in electronic form please find a letter from Aquila's Director-Regulatory Services, Gary L. Clemens, which, among other things, sets forth a list of the rate schedules being filed and explains the purpose of the filing. Two copies of this filing will be provided to the Commission's General Counsel and to the Office of the Public Counsel.


