## ORDER PERMITTING RELINQUISHMENT OF DESIGNATION AS ETC

Issue Date: August 7, 2017 Effective Date: August 7, 2017

On July 7, 2017, the Staff of the Missouri Public Service Commission (Staff) filed a recommendation to cancel the wireless Eligible Telecommunication Carrier (ETC) designation of Budget Prepay, Inc., d/b/a Budget Mobile. Staff attached correspondence from Budget Mobile's counsel notifying the Commission that the company intended "to discontinue providing any and all telecommunications services in the state of Missouri." Included in this correspondence was a notification of relinquishment of its ETC designation as granted in File No. CO-2012-0043 on April 24, 2013.

Budget Mobile is a wireless telecommunications provider but was also granted a certificate of service authority to provide basic local telecommunications service on September 18, 2002, in File No. CA-2003-0024. Budget Mobile was also granted authority to provide interexchange telecommunications service in File No. RA-2009-0375.

In addition to cancelation of its ETC designation, Budget Mobile has requested that its other certificates be canceled. Budget Mobile's request to cancel its basic local

service was granted in File No. CD-2017-0315, and pending File No. XD-2018-0004 concerns its request to cancel its interexchange authority.

The Commission does not have specific rules concerning relinquishing ETC authority but relies on 47 U.S.C. Section 214(e)(4), which states, in part,

A State commission . . . shall permit an eligible telecommunications carrier to relinquish its designation as such a carrier in any area served by more than one eligible telecommunications carrier. An eligible telecommunications carrier that seeks to relinquish its eligible telecommunications carrier designation for an area served by more than one eligible telecommunications carrier shall give advance notice to the State commission...of such relinquishment. . . .

In its letter, Budget Mobile indicated that it sent notice to all of its subscribers in Missouri and that those consumers will have multiple options for alternative wireless service providers, including TracFone Wireless, Q Link Wireless, Assurance Wireless, and Boomerang Wireless. Additionally, Staff states that it "agrees that Budget meets all of the requirements" of 47 U.S.C. Section 214(e)(4).<sup>2</sup> Further, the Commission provided notice to all ETCs in the state of Budget Mobile's request to relinquish its designation and no responses or requests for intervention were filed.

Based on the Staff's recommendation and the attached correspondence, the Commission finds that Budget Mobile shall be permitted to relinquish its ETC designation.

#### THE COMMISSION ORDERS THAT:

- 1. Budget Prepay, Inc., d/b/a Budget Mobile is permitted to relinquish the Eligible Telecommunications Carrier designation granted in File No. CO-2012-0043.
  - 2. This order shall be effective when issued.
