## **ORDER DIRECTING NOTICE**

On February 26, 2002, Quail Run Water and Land Company filed its application seeking authority to sell all of its outstanding shares and to transfer all of its assets to the Public Funding Corporation of the City of Ozark, Missouri. Upon completion of the transaction, Public Funding Corporation intends to sell or lease the purchased system to the City of Ozark, Missouri, which will operate it as part of its municipal system of utilities. Quail Run's customers will continue to receive water service at existing rates. Following the sale, Quail Run intends to cease operation as a public water utility.

The Commission finds that proper persons should be allowed 20 days from the effective date of this order to file a motion for leave to intervene. The Commission determines that notice of this Application should be given by the Commission's Data Center to the County Commission of Christian County, Missouri. The Commission further determines that the Public Information Officer of the Commission should make notice of this Application available to the members of the General Assembly representing Christian County, Missouri, and to the newspapers and other news media serving Christian County, Missouri.

### IT IS THEREFORE ORDERED:

1. That the Data Center of the Commission shall send notice of this Application to the County Commission of Christian County, Missouri.

2. That the Public Information Officer of the Commission shall make available notice of this Application to the members of the General Assembly representing persons residing within Christian County, Missouri, and to the newspapers and other news media which serve that county.
