#### MOTION FOR FINDING OF NECESSITY FOR RULEMAKING

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through its Office of General Counsel, pursuant to section 536.016 RSMo 2000, and for its Motion For Finding Of Necessity For Rulemaking, respectfully states as follows:

Section 536.016 RSMo 2000 provides that a state agency shall propose rules based upon "a finding by the agency that the rule is necessary to carry out the purposes of the statute that granted such rulemaking authority."

- 2. Pursuant to Sections 386.310 and 394.160 RSMo 2000, in order to establish minimum safety standards relating to the operation of electric and telephone utilities and rural electric cooperatives, Commission rule 4 CSR 240-18.010 adopts, in specified part, the 1997 edition of the *American National Standard, National Electrical Safety Code* ("NESC"). The 1997 edition of NESC has been updated.
- 3. Attached as Appendix A is the Staff's notarized affidavit concerning the necessity for this rulemaking.

WHEREFORE, the Staff respectfully requests that the Commission find that the proposed rulemaking is necessary.
