On July 18, 2005, SPB Holdings, LLC, d/b/a State Park Village Wastewater Treatment System, applied with the Commission requesting authority to construct, install, own, operate, control, manage, and maintain a sewer system in an unincorporated portion of Johnson County, Missouri. The proposed service area is a part of a proposed residential and commercial development known as State Park Village.

The Commission finds that proper parties should be given notice and an opportunity to intervene in this matter. The Data Center of the Commission shall send a copy of this order to the County Commission of Johnson County and to the Missouri Department of Natural Resources. The Information Officer of the Commission shall make notice of this application available to the members of the General Assembly representing Johnson County, and to the media serving Johnson County.

Proper persons wishing to intervene shall file an application to intervene with the Secretary of the Missouri Public Service Commission. Copies of the application to intervene should be sent to the parties listed below.

IT IS THEREFORE ORDERED:

1. That the Information Office and the Data Center of the Missouri Public Service Commission shall provide notice as set out herein.
