1. On August 3, 2010, U.S. Water Company ("Company") filed an *Application* with the Commission seeking approval to sell and transfer its water system assets located in Lafayette County, Missouri to the City of Lexington, Missouri.
2. The Commission approved the *Application* on October 6, 2010, subject to the condition that the Commission be notified of the date on which the City of Lexington takes possession of the system.
3. On April 2, 2012, U. S. Water Company closed on the sale of its assets to the City of Lexington, Missouri and the City of Lexington took possession of the system.

**WHEREFORE**, the Applicant, U. S. Water Company, pursuant to the Order Approving the Application, requests that the Commission cancel its certificate of convenience and necessity and its tariff.
